- BACB Certification
- Proof of completion of 5 hours of board approved training in reporting abuse, neglect, and exploitation (meets requirements of *KRS 209*)
- Fees:

LICENSED ASSISTANT BEHAVIOR ANALYST

- Bachelors, Masters, or doctoral degree
- Application for Licensure (Form-1)
- Official* Transcript for all education required for licensure
- BACB Certification
- Proof of completion of 5 hours of board approved training in reporting abuse, neglect, and exploitation (meets requirements of *KRS 209*)
- Annual Supervisory Plan

(Reminder: Annual Report of Supervision to be completed as follows)

- 5 years or more of full-time practice, report to be submitted every 2 years
- Less than 5 years of full-time practice, report to be submitted every year

Temporary Licensed Behavior Analyst

- Application for Licensure (Form-1)

Coursework from a BACB approved program?

- If yes: submit original certified post-secondary transcript
- If no: submit original certified post-secondary transcript & course syllabi for all behavior analytic coursework

- Proof of completion of 5 hours of board approved training in reporting abuse, neglect, and exploitation (meets requirements of *KRS 209*)
- Annual Supervisory Plan

(Reminder: Annual Report of Supervision to be completed at the end of each year of supervision with supervisor)

- Fees:
 - \$100 non-refundable application fee
 - \$200 for license (lasts only 2 years)

Temporary Licensed Assistant Behavior Analyst

- Bachelors, Masters or Doctoral degree
- Application for Licensure (Form-1)

Coursework from a BACB approved program?

- If yes: submit original certified post-secondary transcript
- If no: submit original certified post-secondary transcript & course syllabi for all behavior analytic coursework

- Proof of completion of 5 hours of board approved training in reporting abuse, neglect, and exploitation (meets requirements of *KRS 209*)
- Annual Supervisory Plan

(Reminder: Annual Report of Supervision to be completed at the end of each year of supervision with supervisor)

- Fees:
 - \$100 non-refundable application fee
 - \$100 for license (lasts only 2 years)
